ORDER:

In the G.O. 1st read above, orders were issued revising the Pay Scales of the State Government Employees in the light of the recommendations of the Pay Revision Commission, 1993 with effect from 1st January, 1993 with monetary benefit from 1st April, 1993. In the G.O. 2nd read above among other things the revised Pay Scales 1993 have been given effect to from 1-7-1992 with monetary benefit from 1-4-1993.

2. According to proviso to rule 6(b) of the Andhra Pradesh Revised Scales of Pay Rules, 1993, while fixing the pay in Revised Pay Scales 1993, if the amount of emoluments is more than maximum of the Revised Pay Scales, 1993 the pay shall be fixed at the maximum of the scale, the difference being treated as personal pay. These orders are silent about regulation of this personal pay.

3. In the reference 3rd above the Pay and Accounts Officer, Hyderabad has brought to the notice of the Government that during the scrutiny of the claims under the proviso (ii) of rule 6(b) a doubt has arisen in regulation of this Personal Pay as to whether the Personal pay specified therein has to be absorbed in future stagnation increments or to continue as such. He has further stated that in Revised Pay Scales 1978 and 1986 such personal pay was allowed to be continued till fixation of pay on promotion to the next higher category or next fixation in the revised pay scales.

4. The Government have examined the matter carefully and hereby order that if the pay of an employee is fixed in Revised Pay Scales 1993 under the proviso (ii) of rule 6(b) of Andhra Pradesh Revised Scales of Pay Rules, 1993 exceeds the maximum of the revised scales the difference between the maximum of the revised pay scales and the pay so fixed shall be treated as personal pay to be absorbed in future increases in pay on promotion or future revisions.

5. The following notification will be published in the Andhra Gazette :

NOTIFICATION

1. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Revised Scales of pay Rules, 1993.

2. The amendment hereby made shall be deemed to have come into force with effect on and from the 1st July, 1992.

AMENDMENT

In the said rule, for item (ii) of the proviso to clause (b) of rule 6, the following shall be substituted namely:

"(ii) if the amount of the existing emoluments as so increased under clause (a) is more than the maximum of the Revised Pay Scales of 1993, the pay shall be fixed at the maximum of that scale, the difference shall be treated as personal pay to be absorbed in future increases in pay on promotion or in future revisions."
